Introduction

Thank you for choosing Impact.

This Impact Shooting Table is designed for product photography and other still life. It comprises a collapsible metal frame and a glossy, translucent white plexiglass sheet. The plexiglass easily mounts onto the frame to provide a seamless background. The shooting table's lightweight and collapsible design makes it easy to bring to locations for on-site shooting.

Precautions A

- Please read and follow these instructions and keep this manual in a safe place.
- Do not attempt to disassemble or repair this product.
- Make sure that this product is intact and that there are no missing parts.
- To avoid damage to this product, be careful not to overtighten or improperly thread any of the threaded fittings.
- Do not collapse the metal frame while the plexiglass sheet is inside it.
- Be careful not to trap your fingers when collapsing the metal frame.

Assembling the STS-HT / STS-MT





- 1. Open the metal frame.
- 2. Remove the plastic backing from the plexiglass sheet.
- With either side facing up, insert the plexiglass sheet into the clips at the bottom of the frame.
- Bend the top of the plexiglass sheet forward and insert it into the clips at the top of the frame.

One-Year Limited Warranty
